Blind Veterans

"Blind Veterans UK are ensuring that the most vulnerable veterans we support are receiving everything they need right now. More than 90% of the blind veterans we serve are over 70 and so most at risk from the Coronavirus (COVID-19) in the coming months. As a result our immediate priorities have changed.

"Having to self-isolate, our older beneficiaries need our help right now with daily tasks, such as shopping, medication, and emotional support through this difficult time. For that reason we are temporarily changing our service model and mobilising our staff to provide practical, essential support to help the most vulnerable."
